Regional Asylum Seekers Concession Application New/Renewal/Replacement

Apply for concession fares in regional Queensland

Applicants can complete this form for concession fares on public transport in regional Queensland (outside of the *go* card network).

Before completing this form, check that you meet all eligibility criteria below.

Eligibility criteria

To be eligible for an asylum seeker concession, you must:

- · reside in Queensland; and
- be an asylum seeker according to the Department of Immigration and Border Protection (DIBP) evidenced by holding one of the following:
 - Evidence of Immigration Status (EIS)
 Immicard or
 - a Residence Determination (RD) ImmiCard; or
 - a document issued by the DIBP confirming asylum seeker status; or
 - a document issued by a designated asylum seekers support agency confirming status as an asylum seeker. For example, confirmation of support under the Status Resolution Support Service (SRSS) programme, and
- be aged 18 years old and over, or
- be aged 15-17 years old and not in full time education.

What you need to do

- Step 1 Complete Part A and sign the declaration.
- Step 2 Present your completed form at an approved SRSS, along with your current (EIS) ImmiCard.
- Step 3 If the SRSS verifies your eligibility for a concession, they will apply a concession sticker to your ImmiCard.

You must carry a current ImmiCard with a public transport concession sticker affixed to your card, to purchase and travel on concession fares.

Renewal/Replacement

Your concession sticker is valid until 31 March following the year of issue.

If you continue to meet the eligibility criteria as an asylum seeker after this date, you will need to reapply each year.

Please check the expiry date on your sticker to allow enough time to reapply for concession fares.

It is an offence under the:

- Criminal Code Act 1899 to dishonestly provide information with the intent to defraud. The maximum penalty may include 10 years imprisonment.
- Transport Operations (Passenger Transport) Act 1994 to state anything or give a document to an authorised person if you know it contains false or misleading information.

Please note: The public transport concession sticker is not valid for travel in South East Queensland (SEQ) on the *go* card network. For details on how to travel in SEQ, visit **translink.com.au**.
